

We recently added quite a few new titles to our collection. We updated our older version of the series **Legal Malpractice**, as well as adding **Firearms Law Deskbook**, **Mastering Voir Dire and Jury Selection**, and **Reinventing Witness Preparation** to name a few.

**Firearms Law Deskbook** gives thorough coverage of gun control laws as well as court decisions. Chapters cover the Gun Control Act, the Nation Firearms Act, licenses, records and a summary of all state firearms laws. The deskbook offers helpful tips for identifying, analyzing, and litigating firearm offenses.



The voir dire and jury selection process is one of the most challenging parts of a jury trial. *Mastering Voir Dire and Jury Selection* can help you understand actual plans to achieve a favorable verdict.

And finally, **Reinventing Witness Preparation** shows how the normal approach to preparing witnesses may not actually be the way to handle the case. This book unlocks new ways to approach witnesses, including how to make sure the witness is effectively understood, how to teach witnesses to give well informed,

truthful answers while staying vague, and how to build credibility.

## **Manufactured Homes Online Research Guide**

The Franklin County Law Library has a new online research guide entitled Manufactured and Mobile Homes: Ohio Laws. Apart from public housing, manufactured and mobile homes make up the largest source of low-income homes in the United States, consisting of one-third of all homes sold annually in this country. The guide has links to both the Federal and Ohio laws. In writing this guide, I was surprised at how many legal issues can come up regarding manufactured homes and trailer parks, including consumer law violations, taxes, lease purchase and land contracts, utilities shut-off, eviction, repossession, replevin, and foreclosure. The law library currently has 39 research guides on its website, each one containing links to forms, statutes and regulations, treatises, and related government agencies.
