

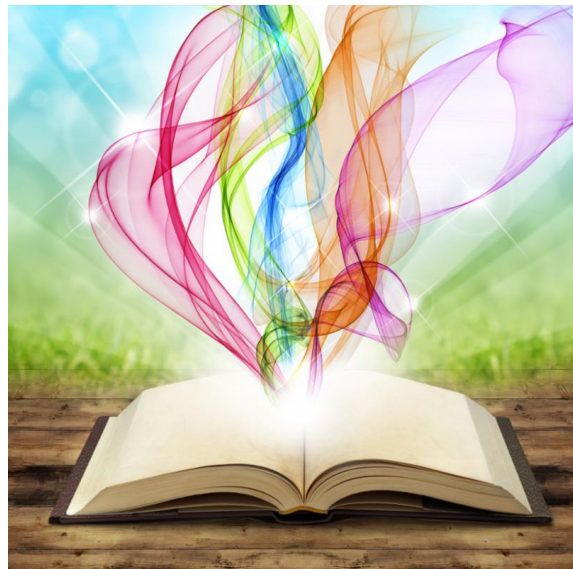

Mechanics' Lien Online Research Guide

The Franklin County Law Library has a new online research guide entitled [Ohio Mechanics' Lien Law](#). This guide has links to [Ohio Revised Code Chapter 1311](#), forms, and a timeline for filing and pursuing a mechanics' lien action. *Ohio Mechanics' and Materialmen's Liens* by R. Russell O'Rourke is a particularly useful book on the topic, located in the law library's collection at call number KFO 155.5 .D57. Although the most recent version of this book is from 2001, it still has very good information. The law library currently has 38 research guides on its [website](#), each one containing links to forms, statutes and regulations, treatises, and related government agencies.
