

November is National Novel Writing Month (NaNoWriMo). This is a nationwide movement that began in 1999. It's a "novel" approach to writing a novel. Participants begin working on their novel November 1 with the goal of having a 50,000 word novel completed by midnight on November 30. Using the NaNoWriMo website, you'll be encouraged to write so many words a day in order to accomplish your goal.

The site provides pep talks and support to help you along the way. NaNoWriMo also provides resources throughout the year to help authors build up to November, including pep talks from some of your favorite published authors.

NaNoWriMo is a 501(c)(3) nonprofit that gladly accepts donations and sells cool merchandise to help aspiring writers. Last year more than 402,000 people participated. Since 1999, 484 novels have been published as a result of the NaNoWriMo process by traditional publishers including Sara Gruen's *Water for Elephants* and Erin Morgenstern's *The Night Circus*.

Now is the time to start that great American novel that's been spinning around in your head. Or visit the NaNoWriMo site for new authors and titles to add to your personal to read list.
