Dear Attorney,

The "American Rule" is that each party pays their own attorney's fees. There are, however, numerous statutes that allow the prevailing party to recover attorney's fees. In addition, the trial judge has discretion to award attorney's fees in cases of civil contempt, according to the Ohio Supreme Court's decision in 219 (1977), and reaffirmed by Planned Parenthood v. Project Jericho, 52 Oh. St.3d 56 (1990).
